The Board of Public Works & Safety met in regular session on Tuesday, March 14, 2023, at 10:00 a.m.

Natalie Berkenstock, Deputy Clerk Treasurer, requested the Board's approval of the **March 7, 2023, meeting minutes**. Brenda Sullivan made a motion to approve the request. James Strietelmeier seconded the motion. Motion passed by a vote of four in favor and zero opposed.

Dave Hayward presented a request from the Columbus Parking Commission for **Leased Parking Rates be modified for parking lots 3 and 10 from \$65.00 per month to \$32.50 per month**. Tom Dell from Columbus Parking Commission was present and talked about the modified rates that would start on April 1, 2023. John Pickett made a motion to approve the recommendation as presented.
