 - > Areas Enforced:
 - 4 Parking Garages approximately 3,000 spaces
 - Downtown metered spaces approximately 1,600 spaces
 - Neighborhood parking permit zones- approximately 3,000 spaces
 - (Free parking options available in parking garages, certain on-street parking areas, and City lots.)
 - > Ways to pay:
 - Smart phone mobile app
 - Credit cards, debit cards, or coins can be used at parking meters and kiosks
 - Rates (Bloomington is pay by plate):
 - Garages- \$0.50/hr commuter rate or Permits - \$110 annually or \$60 monthly
 - Neighborhood permit zoned areas \$49 annually
 - Metered spaces: \$1/hr and a convenience fee of \$0.50 per transaction unless a user is a ParkMobile Pro or Wallet user. – Enforced M-Sat, 8:00am – 9:00pm
 - ➢ Revenue:
 - All metered revenue \$2.8 \$3 million annually
 - Other Parking Service Features:
 - There are mobile app options available to reduce the convenience fee depending on individual usage.
 - QR codes posted to provide a scan to pay option.
 - A pay by phone option is available for those without smartphones.
 - Can use PayPal or prepaid cards.
 - Recommendations for Columbus:
 - Hire parking consultant Collect accurate parking data (who is parking where and when) and provide data to consultant.
